# The Convention

- Police Cooperation Convention for Southeast Europe (PCC SEE)
- Albania, Bosnia and Herzegovina, Macedonia, Moldova, Romania, Serbia and Montenegro
- 5 May 2006 in Vienna
- Entry into force on 10 October 2008
- In force for all Contracting Parties

# History

- Idea of the Austrian Ministry of Interior
- Support by Germany, Europol, Austrian Ministry of Foreign Affairs
- Negotiations between 2004 and May 2006
- Contracting Parties, Croatia and the supporting partners

# PCC SEE – Scope

- Strengthen cooperation
- To fight threats to public security/order
- To prevent, detect, investigate criminal offences
- (Article 1)

# Forms of Cooperation

- Strategic cooperation (e.g. Art. 3, 11, 12, 24)
- Operational cooperation (e.g. Art. 13, 26, 28)
- Special investigation methods (e.g. Art. 14 – 17, 27)
- Mutual legal assistance (Art. 18 – 19)



# Specific Instruments to combat TER and OC

- Art. 5 – Scope of information exchange
- Art. 7 – Joint Threat Assessment
- Art. 10 – Witness Protection
- Art. 14 – Cross-border Surveillance
- Art. 15 – Controlled delivery
- Art. 16 and 17 – Undercover Investigations
- Art. 27 – Joint Investigation Teams

- Support the implementation
- Smooth the application

of the Convention in order to contribute to

- Enhancement of cross-border cooperation
- Improvement of internal security of the Parties of the Convention
