# Chronology of the Yugoslav Conflict

- 1389: Battle of Kosovo Polje**
- 1455-1912: Ottoman empire rules Kosovo**
- 1878: Occupation of B-H by Austrian-Hungarian Empire**
- 1908: Annexation of B-H**
- 28.6.1914: Killing of Austrian Arch Duke Ferdinand in Sarajevo**

# Chronology of the Yugoslav Conflict

- 1974:** Amendment of Constitution of Yugoslavia provides autonomous provinces of Vojvodina and Kosovo
- 1980:** Tito dies
- 1986:** Serbian Academy of Arts and Sciences publishes so called Memorandum
- 1987:** Milosevic's rise to power
- 1989:** The six hundred anniversary of the „Battle of Kosovo“  
Milosevic uses the anniversary to spark the nationalism of its own people

# Chronology of the Yugoslav Conflict

- 1990/1991: Withdrawal of autonomy of Kosovo**
- 1990/1991: Rise of national forces in Slovenia, Croatia and Bosnia and Herzegovina**
- June 1991: Slovenia and Croatia declare independence:  
10 days war in Slovenia**
- 1991-1992: War in Croatia: Fall of Vukovar, Attack on Dubrovnik**
- February 1992: Bosnia and Herzegovina: referendum for independence**
- April 1992: War in Bosnia and Herzegovina started**

# Chronology of the Yugoslav Conflict

**Summer/fall 1992: Concentration camps discovered by western journalists**

**1992-1995: Siege of Sarajevo**

**1993: Washington agreement ends war in Mostar: EUAM**

**1987-2000: Milosevic rules Serbia**

**1994: Sarajevo massacre triggers western intervention**

**1995: Fall of UN “safe area” and genocide in Srebrenica**

# Chronology of the Yugoslav Conflict

- 1995:** Croatian forces liberate occupied part of Croatia
- 1998/1999:** Kosovo liberation army attacks result in increased Serb repression
- 1999:** Rambouillet-conference
- 24.3.-10.6.1999:** NATO intervention in Serbia and Montenegro
- 2000:** Milosevic resigns
- 2001:** Ohrid agreement resolves Macedonian conflict

# Chronology of the Yugoslav Conflict

- 2001:** Milosevic transferred to Hague
- 2004:** Milosevic dies
- 2005:** Montenegro separates from Serbia after referendum
- 17 Feb. 2008:** Declaration of Independence by Republic of Kosovo
- 22 July 2008:** Karadzic arrested in Belgrade

# Human Rights Violations in the Balkans

- **War crimes in Croatia, Bosnia-Herzegovina and Kosovo**
  - **Vukovar**
  - **Dubrovnik**
  - **Sarajevo**
- **Bosnia-Herzegovina: 100.000 dead, 1.5 Mio displaced**
- **Kosovo: 10.000 dead, 1.3 Mio displaced, 800.000 had to flee country temporarily**
- **Srebrenica, July 2005: 8.000 men killed**
