



### Hans-Jörg Albrecht




Hans-Jörg Albrecht is director at the Max Planck Institute for Foreign and International Criminal Law in Freiburg. His research interests cover various legal, criminological and policy topics ranging from sentencing theory, juvenile crime, drug policies, environmental crime and organized crime, evaluation research and systems of criminal sanctions. From 1977 to 1991 he was researcher fellow at the MPI. In 1991 he accepted an offer to lecture criminal law and criminology at the Law Faculty of the University of Konstanz. In 1993 he was offered the chair for criminal law, juvenile criminal law and criminology at the University of Dresden where he stayed until 1997. In 1996 he was elected as director of the MPI. Hans-Jörg Albrecht was given the status of guest professor at the Center for Criminal Law and Criminal Justice of the China University of Political Science and Law, Beijing (April 2000); Law Faculty of the University of Hainan (April 2001); Law Faculty of Renmin University (January 2004); Law Faculty of Wuhan University (May 2005). In May 2003 he was conferred "Life Membership" from Clare Hall College, University Cambridge/UK. In May 2004 he was granted the University of Teheran professorship and permanent faculty membership of the Faculty of Law of Qom High Education Center, Teheran. ### Dejan Anastasijevic



Dejan Anastasijevic is senior investigative reporter for the Belgrade-based VREME weekly, and free-lance Balkan correspondent for TIME magazine. He also contributes to a number of local and foreign news media, including "Slobodna Bosna" (Sarajevo), "Koha Ditore" and "Zeri" (Pristina), and "The Guardian" (London). Anastasijevic started his career in B92 Radio, covering the war in Vukovar (1991) and Eastern Bosnia (1992). In September of 1992, he joined the United Press International (UPI) bureau in Belgrade, where he remained until UPI's bankruptcy in 1993. He then joined the VREME staff, where he still works today. Anastasijevic's 1998 reports on atrocities against ethnic Albanians in Kosovo led to criminal charges by Milosevic's regime for "spreading disinformation and aiding terrorists". In April of 1999, during the NATO bombing and Milosevic's crackdown on free media, Anastasijevic fled to Vienna with his family. He worked in TIME's Central and Eastern Europe Bureau until August 2000. He moved back to Belgrade in time to cover Milosevic's downfall and subsequent transfer to the Hague war crimes tribunal. In October 2002, Anastasijevic was the first Serbian journalist to testify against Milosevic in the Hague. His more recent reports mostly deal with security issues and organized crime in Serbia. Apart from purely journalistic work, Anastasijevic has edited "Out of Time" (IWPR London, 2000), an acclaimed book on Serbian opposition. He is a recipient of 2002 Nieman Fellowship for

### Lars Erslev Andersen






## **Ilir Dugolli**

From September 2002 until October 2004, he was Head of Legal Process at the Housing and Property Directorate, responsible for the regularization of property rights in Kosovo through the adjudication of claims for property restitution and through the administration of abandoned properties for humanitarian purposes. From October 2004 until February 2006, he was Senior Legal Advisor to the Temporary Media Commissioner, at that time the independent media regulatory authority in Kosovo, where he helped establish Kosovo's permanent broadcast regulatory agency, as well as drafted the laws, policies, and guidelines creating the legal framework for freedom of the media and freedom of expression in Kosovo. Dr. Ehrlich was Senior Legal Advisor in the Office of the Head of Mission for the OSCE Mission in Kosovo, providing general counsel to the OSCE Mission on its mandate to build Kosovo's democratic institutions. In this last capacity, he was also an expert advisor to Kosovo's Constitutional Commission, advising on decentralization, economic policy, and independent public institutions.

Prior to working in Kosovo, Dr. Ehrlich served at the Claims Resolution Tribunal in Zurich, Switzerland, where he adjudicated claims to Swiss bank accounts. Besides his practical legal work, he has done theoretical work in comparative constitutional and international law, particularly focusing on the rights of ethnic and cultural minorities. He holds a Doctorate in Modern History from the University of Oxford, a Master's in European Studies specializing in European government and economics from the London School of Economics, and degrees in Law from the College of William and Mary and in History and the Classics from Harvard University.


### **Kurt Hager**



### Josip Kregar



## **Antonija Petricusic**


